#### FIRETRAX SOFTWARE UPGRADE

Councilman Mumford made a motion Council Authorize The Procurement Of The Firetrax Software Upgrade For The Current Accountability Software Used By The Emergency Management Department From The Only Authorized Dealer In South Carolina, Bridgeway Solutions, In The Amount Of \$29,787 Utilizing 2007 Homeland Security Grant Funding. ## GRANT AWARD SOUTH CAROLINA BUDGET AND CONTROL BOARD

Councilman Rodgers made a motion Council Accept The Grant From The South Carolina Budget And Control Board In The Amount Of \$43,237.50 For The Fiscal Year 2008 First Responder Interoperability Grant To Maintain The County's 800 MHz Radio System. Councilman Culberson seconded the motion, which was approved unanimously.

Councilman Rodgers seconded the motion, which was approved unanimously.

## **VOTER REGISTRATION/ELECTIONS OFFICE**

Councilman Schofield made a motion Council authorize the Committee on Public Service & County Planning to begin consideration of the new Voter Registration/Elections Building and proceed with the hiring of an architect and proceed with getting ready for that new facility. Councilman Rodgers seconded the motion, which was approved unanimously.

### **AWARD BID #20-08/09**

Councilman Schofield made a motion Council Accept The Bid Of The Lowest Responsive Bidder, Palmetto Paving, Conway, SC For Baroody Street Parking Expansion In The Amount Of \$98,389.75 To Be Funded From Fiscal Year 09 Landfill/Capital Improvements Fund; And Authorize The County Administrator To Proceed. Councilman Mumford seconded the motion, which was approved unanimously. County Administrator Richard Starks stated this project had been in the works for a long time and should add well over 100 parking spaces at the City-County Complex. Originally, the County thought an engineer would have to be contracted however the Pee Dee Regional Council of Governments did the design work and will assist in monitoring the project, saving the County over \$10,000.
