SOLE SOURCE PROCUREMENT/MICROFORM SCANNERS

Councilman Mumford made a motion Council Approve A Sole Source Procurement Of Three (3) Minolta MS6000 Mk II Digital Film Microform Scanners For The Clerk Of Court's Office From Cavin's Business Solutions Of Fayetteville, NC In The Amount Of \$36,244. Councilman Culberson seconded the motion, which was approved unanimously. Councilmen Caudle and Kirby expressed concerns regarding local bidders.

PROCUREMENT

DECLARATION OF SURPLUS PROPERTY

Councilman Mumford made a motion Council Declare Unit #522, A 1997 Ford Crown Vic, VIN#2FALP71W4VX132262 As Surplus Property For Disposal Via GovDeals Or A Manner Most Advantageous To The County. Councilman Culberson seconded the motion, which was approved unanimously.

Councilman Culberson made a motion Council Declare Various Office Furniture As Surplus Property For Disposal In The Manner Most Advantageous To The County. Councilman Caudle seconded the motion, which was approved unanimously.

TIMMONSVILLE RESCUE SQUAD/PROCUREMENT

AWARD BID NO. 16-13/14

Councilman Kirby made a motion Council Award Bid No. 16-13/14 For The Purchase Of One (1) Certified A-Frame Carport For The Timmonsville Rescue Squad To Newmart Builders, Inc. Of South Hill, VA In The Amount Of \$17,424.60 (Including Tax) To Be Funded By A South Carolina Department Of Health And Environmental Control Grant-In-Aid Grant. Councilman Poston seconded the motion, which was approved unanimously. County Administrator K. G. Rusty Smith, Jr. stated that Newmart Builders was the certified builder but the manufacturer was Weatherly Hardware in Timmonsville, which would be the supplier for the material for this job.

UPDATE ON CPST I

Mr. Smith provided an update on the status of Capital Project Sales Tax I (CPST I). The US Hwy 378 sections 1 and 2 were already let, the contracts were signed and work should be started soon. On the initial phase, \$15 million was saved on the first bid. Sections 3 and 4 were tentatively scheduled to be bid in April 2014. Section 5 would be at a later date, which would move forward, since permits had been received. On US 76 to Timmonsville the low bid was awarded, \$19,008,567.19 went to Palmetto Corporation of Conway and came in \$4,700,000 under budget. The TV Road bids came in at \$23,863,785.86 and saved \$1 million on that with the bid being awarded to C. R. Jackson. He stated Councilman Caudle had been working extensively with SCDOT to assist with Hwy. 51, which was in the property acquisition phase. The 301 Bypass project/Alligator Road preliminary engineering was underway. All of these projects were moving forward, as were the Capital Project Sales Tax II projects.

Councilman Caudle stated he contacted SCDOT and DNR requesting a public access landing at Lynches River and Hwy 378. DNR had not responded yet, but SCDOT and Florence County were committed to do their part to make it publicly accessible for the citizens.

STORM CLEANUP STATUS

Mr. Smith stated storm cleanup was moving quickly. Public works was to be commended for working very quickly to try to handle this in-house with public works staff. The County was trying to save taxpayer's money. Instead of disposing of yard waste/debris in the landfill, operations were set up to grind the debris. The County had a very good relationship with the City of Florence and Drew Griffin and the Mayor were allowing the County to take material to their public works site where they would grind the debris at no cost to the County and provide the mulch for use by citizens at no charge. There was also a site set up at the old landfill site on Papermill Road, which was the site the County was asking citizens with large trailer and truck loads to take their debris. Councilman Poston expressed appreciation and commended citizens in District 2 for their volunteering and getting out to clear roadways at their own expense after the storm. Councilman Kirby commended County public works, the County Administrator and volunteers for the effort they all put in to make it less troublesome for the citizens. Mr. Smith stated the EOC ran exceptionally well and the Sheriff's office did well in maintaining order. The Chair stated he would like to echo the sentiments on Council regarding the County's response to the storm. He said Councilman Springs was not at the meeting today because he had been working around the clock to try to restore power to the citizens affected by the storm.

INFRASTRUCTURE

DOROTHY G. HINES NATURE TRAIL

Councilman Bradley made a motion Council Approve The Expenditure Of Up To \$20,269 From Council District 3 Infrastructure Funding Allocation To Assist The City Of Florence With Asphalting The Dorothy G. Hines Nature Trail. Councilman Mumford seconded the motion, which was approved unanimously.

LAVERNE ARD PARK

Councilman Poston made a motion Council Approve The Expenditure Of Up To \$14,000 From Council District 2 Infrastructure Funding Allocation For The Purchase And Erection Of Perimeter Fencing Around The Football Field At Laverne Ard Park. Councilman Culberson seconded the motion, which was approved unanimously.

TOWN OF COWARD

Councilman Caudle made a motion Council Approve The Expenditure Of Up To \$5,000 From Council District 5 Infrastructure Funding Allocation For The Purchase Of A Camera System For Surveillance Of The Town, Park, Ball Field And Both Water Wells For The Town Of Coward. Councilman Dorriety seconded the motion, which was approved unanimously.

FLORENCE COUNTY MAGISTRATES' OFFICES

Councilman Kirby made a motion Council Approve The Expenditure Of Up To \$5,940 From Council Districts' Infrastructure/Utility Funding Allocations (Approximately \$660 From Each District) To Purchase Bulletproof Vests For Florence County Magistrate Constables To Replace Outdated Vests Currently In Use. Councilman Mumford seconded the motion, which was approved unanimously.

ROAD SYSTEM MAINTENANCE FEE (RSMF)

ARES LANE

Councilman Kirby made a motion Council Approve The Expenditure Of Up To \$5,250 From Council District 6 RSMF Funding Allocation To Pay For Crushed Asphalt For Ares Lane. Councilman Mumford seconded the motion, which was approved unanimously.

EDSEL ROAD

Councilman Culberson made a motion Council Approve The Expenditure Of Up To \$15,000 From Council District 6 RSMF Funding Allocation To Pay For Crushed Asphalt For Edsel Road. Councilman Poston seconded the motion, which was approved unanimously.

POWELL LANE

Councilman Culberson made a motion Council Approve The Expenditure Of Up To \$3,000 From Council District 6 RSMF Funding Allocation To Pay For Crushed Asphalt For Powell Lane. Councilman Mumford seconded the motion, which was approved unanimously.
