A notice of the regular meeting of the Florence County Council appeared in the March 19, 2014 edition of the <u>MORNING NEWS</u>. In compliance with the Freedom of Information Act, copies of the meeting Agenda and Proposed Additions to the Agenda were provided to members of the media, members of the public requesting copies, posted in the lobby of the County Complex, provided for posting at the Doctors Bruce and Lee Foundation Public Library, all branch libraries, and on the County's website (www.florenceco.org).

Chairman Schofield called the meeting to order. Secretary-Chaplain Kirby provided the invocation and Vice Chairman Mumford led the Pledge of Allegiance to the American Flag. Chairman Schofield welcomed everyone attending the meeting.

Chairman Schofield stated he would like to share comments presented to the Legislative Delegation in Columbia on Tuesday, March 18. "It's an exciting time in Florence County. Many good things are happening and the future development of our County has never looked more promising. There are many issues and challenges that we face in Florence County but the one challenge we don't face is the dedication of our elected officials and the Doctors Bruce and Lee Foundation.

The dedication of Senator Leatherman: years upon years of loyal and dedicated service to the people of Florence County and the State, always trying to move us to the next level, always making sure that our voice is heard in Columbia and making sure that the Pee Dee region got its fair share. His success in securing funding for many facilities will never be matched again. Our support for him should never be questioned.

The dedication of the Bruce and Lee Foundation to improving the quality of life in Florence has changed our community forever. I hate to think where we would be without these two irreplaceable assets in our community.

The next five years in Florence County will be very exciting and they will chart the course for many years to come. Major highway improvements in the first capital penny will be the pathways to our future. The economic impact of these highways will last for generations, thanks to the vision and the dedication of Senator Leatherman. New infrastructure projects in the County and the City of Florence have begun transforming and shaping our communities for the better. The pessimism of the past has been put away. A new hope exists in our people; they see things changing in the City of Florence and in Lake City and our other communities, such as the water tank fixing to be built in Pamplico. They see hotels and restaurants being built; they see road and major water and sewer projects, which are the backbone of economic growth. They see people in other organizations investing in our community once again, confident of our County's future. They see a new museum for Florence County getting ready to open and they see a new health science campus for Francis Marion University getting ready to break ground in downtown Florence. Thanks to the efforts of Senator Leatherman, Dr. Carter, the Bruce and Lee Foundation, and the City and the County of Florence.

Just think, you add all of that to what has already been accomplished. I challenge you or anyone to find a county or a city the size ... our size ... that has an equal to McLeod Medical Center and Carolinas Hospital System, or an equal to our Library facilities, Little Theatre, Performing Arts Center, Francis Marion University, or Florence-Darlington Tech with its SiMT facility. Show me any community that during the greatest recession that this Country has ever faced has continued to attract industry such as Otis, Monster, QVC, Johnson Control, and the expansion of our own locally owned McCall Farms. When all of us work together, realizing the opportunity that is before us – not looking

back, not dwelling on past failings – but putting all of our efforts toward our ideas and visions of the future, we surely shall not fail.

Robert Kennedy said 'Some men see things as they are, and ask why ... I dream of things that never were and ask why not?' Shouldn't we all dream things that never were in Florence County and ask 'why not?' It is time to set the bar high. We can achieve it if we work together. Opportunities are unlimited for the person that doesn't know the word 'can't.' We are at the point where we could build the best mega-industrial park in our State. We have seen what happens when an industrial park is built with the entire infrastructure in place. When I was on City Council, the park where Otis Elevator is located today was done and recently, Pee Dee Commerce Park was done by Pee Dee Electric Coop. All it takes is the coordinated will of our elected officials working toward that goal. Our cultural, medical, recreational, transportation, educational facilities, in partnership with this new park, would put us at the top of the list when industry comes calling. Why not look forward, lock our hands together, and make our community one of the best in South Carolina? We have the time, we have the talent, and we have the resources. Let us all commit to a common goal that, together, we are going to make Florence County the best there is in South Carolina. I assure you that Florence County Council will do all that it can to work with all of you to move our community forward and develop the full potential of our citizens and our resources."

# ORDINANCE NO. 17-2013/14 – SECOND READING

The Clerk published the title of Ordinance No. 17-2013/14: An Ordinance Dissolving Pursuant To Section 4-9-30(5)(E) Of The Code Of Laws Of South Carolina, 1976, As Amended, The Sardis-Timmonsville Rural Fire Protection District, And Dissolving The Johnsonville Rural Fire District, The Howe Springs Fire District, The Hannah-Salem-Friendfield Fire District, The West Florence Rural Fire District, And The Windy Hill/Olanta Rural Fire District, All Incident To The Establishment Of The Florence County Fire Protection District As A Special Tax Fire District Under Article 19 Of Title 4 Of The Code Of Laws Of South Carolina, 1976, As Amended, Providing For The Conditions With Respect To Said Dissolution, And Other Matters Related Thereto. Councilman Caudle made a motion Council approve second reading of the Ordinance. Councilman Culberson seconded the motion, which was approved with a five (5) to four (4) vote. Voting in the affirmative were Chairman Schofield, Councilmen Culberson, Poston, Caudle, and Springs. Voting 'no' were Councilmen Bradley, Mumford, Kirby and Dorriety.

# ORDINANCE NO. 18-2013/14 – SECOND READING

The Clerk published the title of Ordinance No. 18-2013/14: An Ordinance To Create And Establish The Florence County Fire Protection District In Florence County, South Carolina Pursuant To Title 4, Chapter 19 Of The Code Of Laws Of South Carolina, 1976, As Amended, To Approve The Annual Levy And Collection Of Ad Valorem Taxes And The Imposition Of Rates And Charges For The Operation And Maintenance Thereof, To Authorize The Issuance Of General Obligation Bonds On Behalf Of The District From Time To Time, And Other Matters Relating Thereto. Councilman Caudle made a motion Council approve second reading of the Ordinance. Councilman Poston seconded the motion, which was approved with a five (5) to four (4) vote. Voting in the affirmative were Chairman Schofield, Councilmen Culberson, Poston, Caudle, and Springs. Voting 'no' were Councilmen Bradley, Mumford, Kirby and Dorriety.

The Chair commented that third reading of these two Ordinances would be deferred at the next meeting and would be deferred until further down the road when Council had clear knowledge of the legal options and a better idea of legislation being considered in Columbia.

#### ADD FIVE POSITIONS FOR SHERIFF'S OFFICE

Councilman Mumford made a motion Council Approve The Addition Of Four (4) Corrections Officer Positions And One (1) Reception Clerk Position To The Florence County Sheriff's Office Budget, Effective March 29, 2014. Councilman Caudle seconded the motion, which was approved unanimously. County Administrator K. G. Rusty Smith, Jr. informed Council that this was in response to another State mandate that required the County to put in seventeen more correctional officers, with no funding from the State to do so. He commended Chief Deputy Kirby and Finance Director Kevin Yokim for their efforts in August, 2013, to propose an increase in per diem to help off-set the cost.
