Chairman Schofield informed Council that the bonds for the Capital Project Sales Tax II were sold and should close in the next couple of weeks. The citizens of Florence County received a very favorable interest rate on those bonds. The County should begin receiving funds about the time that the penny would begin to pay for the bonds on May 1<sup>st</sup>. Councilman Dorriety asked if the County would receive a premium on the bonds. Mr. Smith responded that it would be around \$12.5 million, due to the fact that IRS regulations wouldn't allow more than 10%. The low bidder was J.P. Morgan Securities, LLC.

Councilman Kirby made a motion Council Approve The Use Of Contingency Funds To Complete The Master Plan For The Wildlife Center And Related Items At The Lynches River County Park. Councilman Caudle seconded the motion, which was approved unanimously.

### HANNAH-SALEM-FRIENDFIELD FIRE DEPT./PROCUREMENT

#### **PURCHASE FIRE PUMPERS**

Councilman Poston made a motion Council Authorize The Purchase Of Six (6) Fire Pumpers And The Necessary Equipment From The Houston-Galveston Area Council (HGAC) Cooperative Purchasing Program For The Hannah-Salem-Friendfield Fire Department In An Amount Not To Exceed \$2,700,000 As Funded In The Capital Project Sales Tax II. Councilman Culberson seconded the motion, which was approved unanimously. Mr. Smith stated for the record that any future rolling stock purchases for tankers may be foregone due to this allocation and the Fire Chief was aware of that fact. In response to questions from members of Council, Mr. Smith responded that the total allocation for Hannah-Salem-Friendfield Fire District under the CPST II was \$4,045,000; the six (6) pumpers would be \$2,673,500, which would leave a balance of \$1,371,500. If you take off the four (4) tankers, the balance would be \$371,500, but the buildings were projected to cost \$960,000 according to the architect so there would be a shortage of \$528,000 and that was why he said future rolling stock purchases would be foregone. Councilman Bradley stated that he wanted to remind everyone that as the process continued it was very important to the public that local and minority businesses play a part in the process.
