#### FIRE DEPARTMENT REPORT

At The Request Of Council, County Administrator K. G. Rusty Smith, Jr. Provided A Brief Report Regarding The Status Of The FY2015 Funds Disbursements To The Fire Districts. Contracts had been executed for all fire departments, with the exception of West Florence and South Lynches. In accordance with the contracts, on July 1<sup>st</sup>, checks were processed to each of six fire departments for four (4) months of the FY2015 budget as approved by Council. West Florence did not sign a contract with Florence County and they were paid the property taxes collected during the last half of June and the month of July under the current 8 mil tax level, which was the same amount they would have received if consolidation had not taken place. The attachment included in the Agenda packet also included South Lynches information. No action was required or taken by Council on this matter.

#### PURCHASE OF CATERPILLAR MOTORGRADERS

Councilman Bradley made a motion Council Approve The Use Of The National Joint Powers Alliance (NJPA) Cooperative Alliance (NJPA) Cooperative Purchasing Program To Procure Three (3) 2015 Caterpillar Motorgraders Using NJPA Contract No. 060311-CAT From Blanchard Machinery Of Florence, SC In The Total Amount Of \$760,049 (Including Tax) From The FY2014-15 Budgeted Funds And Authorize The County Administrator To Execute The Contract. Councilman Culberson seconded the motion. Councilman Mumford stated he hated to do this, but Council had no other choice at this time because the funds for these much needed Motorgraders were needed for other things. Councilman Mumford made a motion to amend the motion to Approve The Purchase Of One (1) Motorgrader Now And Roll Over Two (2) To A Later Time Because Of A Shortage Of Funds. Councilman Culberson seconded the motion. The Chairman asked for clarification if potentially a 'later time' could be within this year. Councilman Mumford stated that was correct. Approval of the motion as amended was approved unanimously.

#### SELF-CONTAINED BREATHING APPARATUSES

Councilman Mumford made a motion Council Authorize The Purchase Of Eighty-Six (86) MSA G1 4500 PSI Self-Contained Breathing Apparatuses (SCBA) And Other Related Equipment From Newton's Fire & Safety Equipment, Inc. Of Swepsonville, NC Off Of The Houston-Galveston Area Council (HGAC) Cooperative Purchasing Program For The South Lynches Fire District In An Amount Not To Exceed \$499,807.15 (Including Sales Tax) As Funded In The Capital Project Sales Tax II. ## **ADMINISTRATION**

## **GREENWOOD MANNED CONVENIENCE CENTER (MCC) SITE**

At The Request Of Council, The County Administrator Provided A Brief Update On The Status Of The Greenwood MCC Site. Mr. Smith stated the Agenda Addendum packet included a chronological index of the Greenwood MCC Site. The County acquired additional acreage beside the existing site. Utilized in the design for improving the site was 42,784 square feet. Design options were provided and Councilman Caudle selected design option 2. The engineering cost estimate was \$331,250 not including engineering. Public Works cost estimate was \$405,478, which does include the engineering cost. The additional property was utilized during the most recent ice storm to handle the storm debris. The project would require an engineering firm to design and provide a construction drawing before Florence County could bid the project. Staff would need a direction or path forward as to how Council would like to move forward with the project. Councilman Caudle was unable to attend the meeting but asked that Mr. Smith provide the information. The Chairman stated Council would receive as information and directed that staff try to get it on the next agenda to figure where to go from here.

#### DECLARATION OF SURPLUS PROPERTY

Councilman Dorriety made a motion Council Declare A Generac Phase 3 Generator, Serial Number 89A91270-S 364, As Surplus And Authorize Disposal By Public Internet Auction On GovDeals As Requested By The Facilities Management Department. Councilman Culberson seconded the motion, which was approved unanimously.

## SOLE SOURCE PROCUREMENT

Councilman Mumford made a motion Council Authorize The Award Of A Sole Source Procurement To Montgomery Technology Systems, LLC For Upgrades To The Jail Door Controls At Florence County Detention Center In The Amount Of \$243,120 To Be Funded From Capital Project Sales Tax II Funds Approved For Florence County Sheriff's Office. Councilman Dorriety seconded the motion, which was approved unanimously. Sheriff Boone stated this was a software upgrade that was needed for the jail controls.

The Sheriff stated "Publicly, I'd just like to tell you, Council, that I appreciate the relationship that we have. You are a tremendous ally for us and the things you've done for our employees. I just wanted to publicly tell you for everything that you have done for us, it means a lot. Our employees ... our morale is up. Knowing that you care about them as much as I do and I just want to tell you, too, how much I appreciate y'all helping us. The relationship that I have with y'all and particularly the relationship we have with the Administrator. Things, and you've seen us on the agendas a lot over the past year, we've got a lot of good things going on at the Sheriff's Office and thanks to you, particularly the Administrator who has been with us and been a tremendous ally helping us. I just want to publicly tell y'all how much I appreciate it; y'all been good to us. Going around the State, speaking with other Sheriff's, some of them might not have the relationship we have in Florence County, but I am telling you I am very proud to have and blessed to have the relationship we have with y'all and being able to work good together for everything and it is better for Florence County. It is obvious that we think a lot of this County and we are moving forward." Chairman Schofield stated he wanted to thank the public for voting for the Capital Project Sales Tax, which afforded the Council the opportunity to make these type improvements.

#### **COUNTY ADMINISTRATOR**

#### UPDATE ON VARIOUS PROJECTS/PROGRAMS

Mr. Smith informed Council of the following items:

- On August 12<sup>th</sup>, staff met with the 3<sup>rd</sup> Project Manager assigned to the Capital Project Sales Tax I projects by SCDOT, Mr. Dix. They developed a comprehensive project update to enlighten Council and allow Council to address constituents' concerns.
- The On-Site Health Clinic was quickly becoming one of the greatest benefits for the County's most valuable asset, the employees. There were 127 visits in July alone. The estimate in savings to employees was over \$70,000. The County started a Weight Watchers program and was working on a smoking cessation program and a fitness center.
- He had put together a Committee, involving all emergency personnel to work on an updated, workable, comprehensive emergency evacuation program.
