## **ORDINANCES:**

# **ORDINANCE NO. 05-2014/15**

The Clerk published the title of Ordinance No. 05-2014/15: An Ordinance To Amend Ordinance No. 01-2014/15 In Order To Increase The Millage Rates Previously Levied For Fire Protection Services And Other Matters Related Thereto.

Councilman Caudle questioned if the wording should be 'increase' or 'adjust' the millage. He said if the millage went up and then everything worked out it could be adjusted back down. Councilman Culberson stated that was something that could be discussed and decided prior to final reading and approval of the Ordinance. Councilman Bradley asked if it would be an increase in every district. Chairman Schofield stated it was an increase in every district except Johnsonville; very little in Windy Hill, Olanta, and Howe Springs.
