## **ADMINISTRATION**

#### **CPST I & II UPDATE**

County Administrator K. G. Rusty Smith, Jr. provided a brief update on the Capital Project Sales Tax projects I and II progress.

## DEPARTMENT HEADS MEETING

Mr. Smith also provided a summary of the most recent meeting with department heads.

# PEE DEE CANNONS AD HOC RECOVERY COMMITTEE

Mr. Smith provided an update on the recovery of the Pee Dee Cannons from the Pee Dee River that were scheduled to be exhibited at the Veterans Park. The County was requested to establish an Ad Hoc Recovery Committee to work with representatives from the University to inform the community of the recovery process, as well as provide important information pertaining to their history, conservation and future exhibit plans. It was requested that members of the committee be as follows: three (3) representatives from Drs. Bruce and Lee Foundation, two (2) representatives from Florence County Council and two (2) additional appointees made by the Chairman of County Council. It was anticipated the start date for the recovery of the cannons would begin the week of July 13<sup>th</sup>. Chairman Poston stated that with the consent of Council he would make the appropriate appointments.

## JUDICIAL CENTER SELECTION COMMITTEE

Mr. Smith provided a progress report on the judicial center. The Judicial Center Advisory Committee was formed in early 2014 to work with the architects on the schematic design of the courthouse phase. Five (5) members of the Judicial Center Advisory Committee agreed to serve on the Judicial Center Selection Committee to select the construction manager at-risk. Those members were Solicitor Ed Clements, Clerk of Court Connie Shearin, Resident Circuit Court Judge Michael Nettles, Vice Chairman James Schofield and Administrative Services Director Suzanne King. This Committee would review the qualification statements received from contractors and short-list the firms, then schedule interviews with the firms to further reduce the list of contractors for the manager at-risk process.

## **HWY. 76 CORRIDOR ENHANCEMENT**

Mr. Smith provided an update on the Hwy. 76 Corridor Enhancement project. One of the first items for consideration would be the possibility of a zoning initiative for the area. Planning Director Jay Graham was asked to meet with the two (2) Council members of that area to present information relative to the initiative.

Councilman Dorriety made a motion Council Approve The Expenditure Of \$225,000 In State Accommodations Tax Funding Allocations As Recommended By The Accommodations Tax Advisory Committee For FY2015/2016. Councilman Springs seconded the motion, which was approved unanimously.

# PARKS & RECREATION/PROCUREMENT

#### **AWARD BID NO. 30-14/15**

Councilman Dorriety made a motion Council Award Bid No. 30-14/15 For Rubber Surfacing For Ebenezer Park To Creative Playscapes Of Matthews, SC In The Amount Of \$96,812 From The Capital Project Sales Tax II Funds. Councilman Kirby seconded the motion, which was approved unanimously.

# **PROCUREMENT**

#### **AWARD BID NO. 25-14/15**

Councilman Mumford made a motion Council Authorize The Award Of Bid No. 25-14/15 For Capital Project Sales Tax II Section XII And District 7 Road Paving Projects In The Amount Of \$3,232,709.47 To Wade-Lott, Inc. Of Conway, South Carolina To Be Funded From Capital Project Sales Tax II Funds. Councilman Bradley seconded the motion, which was approved unanimously. For clarification, Councilman Mumford stated that \$374,544.53 would be from Council District 7. Councilman Caudle asked who would be responsible for supervising and inspecting this work to ensure it was completed to the appropriate standards. Mr. Smith responded that County Public Works would oversee and also the next item on the Agenda (Contract Approval) was to ensure construction oversight on the projects according to the specs. Councilman Kirby asked if there was a projected completion date on these road projects. Mr. Smith responded 240 days. Councilman Mumford commended Project Manager Mike Meetze and Mr. Smith for the efforts put forth to reduce costs and ensure projects were completed to standards as expeditiously as possible. Councilman Bradley expressed appreciation for the efforts Mr. Meetze put forth in District 3. He went beyond just overseeing the projects, he went into the community to alleviate concerns and answer questions.

# **CONTRACT APPROVAL**

Councilman Springs made a motion Council Authorize ICA Engineering From The Engineering On-Call List To Provide Construction Engineering And Inspection Services (CEI) For Various Road Paving Projects In The Amount Of \$75,000 To Be Funded From Capital Project Sales Tax II Funds. Councilman Dorriety seconded the motion, which was approved unanimously.

## SOLICITATION FOR REPLACEMENT - MAIN SWITCHGEAR

Councilman Schofield made a motion Council Approve Solicitation For Replacement Of The Main Switchgear In The County Complex To Be Funded From Building Commission Funds At An Estimated Cost Of \$1,000,000. Councilman Dorriety seconded the motion, which was approved unanimously. In response to questions from Councilman Dorriety, Mr. Smith replied that this project would basically deplete the fund balance from this fund and confirmed that the project would be bid.
