### • Staff Analysis:

There is a disparity in the Zoning Ordinance between rural and urban applications of the existing accessory structure requirements.

Staff has created a more flexible schedule for accessory structures that addresses the current inequity discovered between the rural and urban settings.

### • Staff Analysis:

The State of South Carolina, consistent with the national building code requirements, has adopted the 2015 International Building Code® series, the 2014 edition of the National Electrical Code® and the 2009 International Energy Conservation Code® with an effective date of July 2016 as the SC State Building Code.

South Carolina State Law requires that all local governments enforce the South Carolina State Building Codes. PC#2016-09 ratifies the State Law and the State Building Code requirements on the local level to effect enforcement authority as required.
