Quotation needed for:

Resurfacing – Hot Laid Asphalt Concrete Surface Course Road
Location: Murray Hill Road

Minimum Specifications:

Project must be completed within 30 calendar days after notice of award

Place extension rings on existing manhole covers and valve boxes to equal asphalt finish grade.

Copies of all asphalt weight tickets must be turned over to Florence County on site.

Repairs will be paid for on a square yardage. Areas to be repaired will be marked by Florence County. Remove damaged asphalt and 6" of base material. Add compacted stone and level to existing asphalt grade.

Any changes or discrepancies must be brought to the attention of Florence County before resurfacing begins. Any changes to the quantities must be approved in writing by Florence County.

Payment to contractor will be based on tons of asphalt and area of repairs listed in the contract.

Bid award will be based on the total price for all sites (if applicable) as one (1) entity.

Asphalt shall be SCDOT Type B. Use 165 lbs/sy.

Tack coat required by Florence County.

**All required shoulder clipping, brooming and clean up included in Bid.
Location map and drawing included.**

Minimum Specifications (cont.):

PERFORMANCE BOND

If the contract price exceeds \$25,000, a performance bond in the full amount (100%) of the contract price shall be executed and submitted to the Florence County Procurement Office within 15 days from contract award date. Cash or a certified check, in the full amount of the contract price, may be submitted as part of the contract in place of a bond within 15 days from contract award date. Failure of the contractor to satisfactorily fulfill his obligations shall be cause for the forfeiture of the guaranty.

PAYMENT BOND

A payment bond in the amount of 100% of the contract price shall be executed and submitted to the procurement officer within 15 days from contract award date for any project where the construction contract price exceeds \$25,000.

INSURANCE REQUIREMENTS

The contractor shall agree to hold harmless, indemnify and defend Florence County, its agents and employees from any claims for property damage or personal injury (including death resulting therefrom). Such claims include, but are not limited to, actual, consequential, incidental or punitive damages. The contractor shall agree to maintain sufficient comprehensive general liability insurance, naming Florence County as additional insured in the amounts of \$1,000,000.00 per occurrence and \$1,000,000.00 per person. Proof of such insurance shall be given to the Florence County Procurement Office by an appropriate certificate-of-insurance issued by the contractor's insurance agent.

Further, the contractor shall agree to insure prior to commencement of work on the project (job), all subcontractors, agents, assigns or employees of prime contractor and subcontractor shall agree to hold harmless, indemnify and defend the City of Florence, South Carolina, its agents and employees from any claims for property damage or personal injury (including death resulting therefrom). Such claims include but are not limited to, actual, consequential, incidental or punitive damages. Further, prior to commencement of work on the project (job), the contractor shall insure that all subcontractors, agents or assigns of the contractor, maintain sufficient comprehensive general liability insurance, naming the City of Florence, South Carolina, as additional insured, in the amounts of \$1,000,000.00 per occurrence and \$1,000,000.00 per person. Proof of such insurance shall be given to the Procurement Officer by an appropriate certificate-of-insurance issued by applicable entity's insurance agent.

With regards to comprehensive general liability insurance, claims may be made during or after the term or terms of the contract agreement.

Minimum Specifications (cont.):

Vehicle liability insurance with minimum combined single limits of \$1,000,000.00 per occurrence shall be maintained by the contractor.

The contractor shall obtain and maintain, during the life of the contract agreement, workers' compensation and employer's liability insurance for all employees to be engaged in services on this project under this agreement in an amount not less than the minimum allowed by South Carolina law, and in case any such services are sublet, the contractor shall require the subcontractor(s) similarly to provide workers' compensation and employer's liability insurance for all of the subcontractor's employees to be engaged in such services.
