REQUEST FOR QUALIFICATIONS (RFQ) FOR PROFESSINAL ENGINEERING SERVICES

Florence County is accepting letters of interest and statements of qualifications from qualified engineering firms to provide professional services on an "as needed" basis in connection with various future county engineering projects. Interested firms are invited to submit qualification statements in accordance with this solicitation.

SUBMITTALS OF QUALIFICATIONS must be submitted no later than 3:00 p.m. EST on Thursday, September 19, 2013 to the address below. Submittals shall contain one (1) original and five (5) copies of the information requested. Submittals received after the deadline will not be opened. Facsimile or e-mail submittals will not be accepted. All submittals should be sent to:

Qualification statements must be submitted to Florence County Procurement in accordance with the date and time outlined above. Respondents to this request for qualification statements will be publicly identified at that time. Qualification statements must be submitted in a sealed envelope with the following information on the envelope:

Florence County reserves the right to engage in discussions with any or all responsible responders who submit resumes which appear to be eligible for award, for the purpose of clarification to assure full understanding of and responsiveness to the request for qualification requirements herein.

This request for qualification statements does not commit Florence County to award a contract, to pay any cost incurred in the preparation of qualification statements or to procure or contract for the articles of goods or services. Florence County reserves the right to accept or reject any or all qualification statements received as a result of this request, to negotiate with any or all qualified offerors, or to cancel in part or in its entirety this solicitation, if it is in the best interest of the County to do so.

GENERAL INFORMATION

- 1. Florence County is soliciting qualification statements from firms to provide Professional Engineering Services on an "as-needed" basis. Examples of projects may include, but are not limited to:
 - County roadway design experience
 - Roadway rehabilitation and/or resurfacing experience
 - Traffic engineering design assistance
 - Assistance with economic development projects
 - Drainage improvement experience
 - Storm water planning
 - Site improvements
- 2. The selection of the firm(s) will be made in accordance with the Florence County Procurement Codes and Regulations.
- 3. Qualification statements will not be accepted from any firm, company, individual, person or party, parent or subsidiary, against which the County has an outstanding claim, or a financial dispute relating to a prior contractual performance with the County.
- 4. The successful firm must be licensed in the state of South Carolina to perform this type of engineering services.
- 5. Six (6) copies of the qualification statement must be delivered to the County by 3:00 p.m. on September 19, 2009. The qualification statement may be:

Offerors mailing a qualification statement should allow sufficient mailing time to ensure timely receipt. The County is not responsible for qualification statements delayed by mail and/or delivery services of any nature. Qualification statements received after the set time for closing will be returned unopened.

- 6. Qualification statements must be made in the official name of the firm or the individual under which business is conducted (showing the official business address) and must be signed in ink by a person duly authorized to legally bind the person, partnership, company or corporation submitting the qualification statement. Qualification statements must be valid for a minimum of ninety (90) days.
- 7. Qualification statements may be withdrawn by offeror prior to, but not after, the time set for the opening.
- 8. Upon receipt by the County, the qualification statement shall become the property of the County, without compensation to the offeror, for disposition or usage by the County at its discretion. The County shall have the sole discretion in evaluating both the qualification statement and the qualifications of the offerors. The County reseves the right to reject any and all qualification statements and is not bound to accept any qualification statements, if the qualification statement acceptance is contrary to the best interest of the County. The particulars of any qualification statement will remain confidential until a contract is signed with the successful offeror(s).

INFORMATION REQUESTED:

Florence County intends to make its selection from among eligible firms that submits an updated Standard Forms 330 (included in this package) along with a letter of interest. Firms wishing to be considered must also submit a brief letter of interest, not to exceed three (3) typewritten pages, describing why the firm is particularly well qualified to perform these services at the time. This letter of interest, a list of no more than five (5) relevant projects being completed in the past ten (10) years, and the Standard Form 330 shall comprise the qualifications package. Six (6) copies of the package shall be submitted. Special binders and covers are not encouraged, and are typically discarded prior to review of the package.

- 1. Name, address, phone number, e-mail, fax number, type of ownership, number of years in business and principals, including names, titles, education, experience and technical competence, as evidenced by resumes and experience records.
 - Type of entity
 - Brief history
 - Location
 - Number of Employees
 - Area of expertise
 - Staff members anticipated to actively work on project

Resumes of individuals who will be assigned to provide services to Florence County and who have the experience and level of expertise needed to perform the services required for these type projects must be included. Limit resume to a single sheet (1 page). At a minimum, provide name, title, project assignment, education, current license(s) and any other experience and qualifications relevant to this project assignment. Individual(s) should have experience with the engineering of five (5) relevant projects within the last ten (10) years. Failure to comply with this section can result in a response being designated noncompliant.

- 2. The firm's capabilities, specialized experience, and technical competence in the engineering services of similar facilities. Provide previous similar project descriptions performed demonstrating the experience and level of expertise applicable to this project. Provide project name and location, project description, date of services and services provided.
- 3. Provide references of clients where similar engineering services were provided in the past ten (10) years relative to the project described herein including contact name, job title, and telephone number, and start and completion dates.
- 4. Past experience and satisfactory performance on contracts with Florence County and/or public agencies.
- 5. Has respondent ever failed to complete an engagement for engineering services or defaulted on a contract to provide engineering services? If so, please describe the circumstances.
- 6. Signed statement attesting that the qualifications submitted are statements of fact including name, title, signature and date.

SELECTION:

The following is a list of criteria that will be used in evaluating qualifications. Respondents will be evaluated on the Statement of Qualifications submitted. Florence County shall be the sole judge of the relative weight of the evaluation criteria. The order of this list does not represent which criteria are most important. Submittals will be evaluated in accordance with criteria specified.

- 1. Relevant successful experiences of engineering firm, with emphasis on proven operational efficiency.
- 2. Evidence of relevant experience of staff to be assigned to project.
- 3. Feedback from users of the Firm's relevant projects now in operation.
- 4. Financial stability.
- 5. Compatibility with County staff and work practices.

Negotiations will be initiated with the top ranked firm(s).

Only firms licensed to do business in South Carolina and are able to demonstrate professional licensing in the disciplines to be supplied will be considered. Failure to meet this requirement will result in disqualification.

Florence County reserves the right to accept or reject any or all Statements of Qualifications in whole or in part and to amend or supplement this RFQ. Florence County is under no obligation to use a firm for a particular project in the future and may select other firm(s) to do future work.

NOTE: By submission of your letter of interest and qualification statements in response to this announcement, you are certifying that neither your firm nor any of its principals are presently debarred, suspended, proposed for debarment, declared ineligible, or excluded for participation in this procurement process by any governmental department or agency. Further, if such a debarment or suspension occurs during the course of the procurement, you shall so inform Florence County.

NOTE: No offeror shall, directly or indirectly, engage in any conduct (other than the submission of a proposal or other prescribed submissions and/or presentations before the Evaluation or Selection Committees) to influence any employee or elected official of Florence County concerning award of a contract as a result of this solicitation. Violation of this prohibition may result in disqualification of the offeror from further participation in the solicitation for services or goods sought herein, or from participation in future Florence County solicitations or contacts.

PROFESSIONAL INSURANCE REQUIREMENTS AND INDEMNIFICATION:

The successful firm(s) shall procure and maintain insurance for protection from claims under workers' compensations acts; claims for damages because of bodily injury including personal injury, sickness or disease, or death of any and all employees or of any person other than such employees; claims for damages because of injury to or destruction of property, including loss of use resulting therefrom; claims caused by professional errors, acts, or omission; and any other insurance prescribed by law. The successful firm shall name Florence County, South Carolina, its elected and appointed officials, officers, and employees "Additional Insured" as their interests may appear but only with respect to services performed or provided by successful firm on behalf of the County under Consultant's commercial general liability insurance policy. The successful firm shall, within 10 days of the full execution of any contract resulting from this RFQ,

provide the County's Procurement Officer with a certificate(s) of insurance evidencing the coverage required above and containing an endorsement to the effect that any cancellation or non-renewal shall not be until 10 days after the insurer or the selected firm gives written notice to the County.

Without limiting the provisions of paragraph above, the selected firm shall during the term of any contract resulting from this purchase and maintain insurance with limits not less than those set forth below:

The successful firm(s) shall take out and maintain, during the life of the contract agreement, workers' compensation and employer's liability insurance for all employees to be engaged in services on this project under this agreement in an amount not less than \$1,000,000.00, and in case any such services are sublet, the firm(s) shall require all subcontractor(s) also to provide workers' compensation and employer's liability insurance in an amount not less than \$1,000,000.00 for all of the subcontractor's employees to be engaged in such.

Employer's Liability Insurance - \$1,000,000 each accident, \$1,000,000 disease policy limit, \$1,000,000 disease each employee

Commercial General Liability Insurance - \$1,000,000 per occurrence (bodily injury and property damage) / \$1,000,000 general aggregate

Automobile Liability Insurance - \$1,000,000 combined single limit (bodily injury and property damage), each accident

Professional Liability Insurance - \$1,000,000 per claim / \$1,000,000 general aggregate

Professional Services: The selected firm(s) shall indemnify and hold Florence County, South Carolina, its elected and appointed officials, officers, and employees, harmless from and against judgments, liabilities, damages, losses, costs, and expenses (including, but not limited to, reasonable attorneys' fees and costs but only to the extent otherwise authorized by law) to the extent caused by any negligent act, error, or omission in the performance and furnishing of the selected firm's professional services under any contract resulting from this RFQ, including any negligent act, error or omission of any individual or entity directly or indirectly employed by the selected firm(s) to perform any of the work or anyone for whose acts, errors, or omissions the selected firm(s) may be liable, regardless of whether or not caused in part by a party indemnified hereunder.

Other Than Professional Services: With respect to all acts or omissions of the selected firm(s), or any individual or entity directly or indirectly employed by the selected firm(s) to perform any of the work or anyone for whose acts, errors, or omissions the selected firm(s) may be liable, which do not arise out of or result from the performance of professional services, and which may be covered by employer's liability insurance, commercial general liability insurance, automobile liability insurance, or other general liability insurance, the selected firm(s) shall indemnify and hold the Florence County, South Carolina, its elected and appointed officials, officers, and employees,, harmless from and against judgments, liabilities, damages, losses, costs, and expenses (including, but not limited to, reasonable attorneys' fees and costs but only to the extent otherwise authorized by law) to the extent caused by or arising out of the selected firm's negligent acts of commission or omission (or those of or any individual or entity directly or indirectly employed by the selected firm to perform any of the work or anyone for whose actions or failure to act the selected firm may be liable) during the performance of this Agreement.

The selected firm shall require any subconsultants (if any) to purchase and maintain insurance with limits not less than those required above to be purchased and maintained by the selected firm. In addition, the selected firm shall require any subconsultants (if any) to assume the selected firm's indemnification obligations under any contract resulting from this RFQ to the extent they relate to the subconsultant's obligations under any contract with the selected firm.

- 17. Current Professional Registration. Provide information on current relevant professional registration(s) in a State or possession of the United States, Puerto Rico, or the District of Columbia according to FAR Part 36.
- 18. Other Professional Qualifications. Provide information on any other professional qualifications relating to this contract, such as education, professional registration, publications, organizational memberships, certifications, training, awards, and foreign language capabilities.

Provide information on up to five projects in which the person had a significant role that demonstrates the person's capability relevant to her/his proposed role in this contract.
