General Questions:

- Does the County have space temperature setpoint guidelines? <u>We did at one time</u>.
- What is included in the Maintenance contract with Cayce Mechanical? <u>This maintenance</u> <u>agreement covers all labor and parts for Temperature and Humility Control, Air Conditioning</u> <u>Units, Air Filters, Heating System (Elect/Gas/Oil), Compressor Change Out, Coil Cleaning/Cooling,</u> <u>Boilers, and Water Treatment.</u>
- Can you verify that the Public Service Building controls are all pneumatic, other than the Chiller and chilled-water pumps? <u>All controls are pneumatic</u>

Law Enforcement Center:

- What is the current inmate population? 271 inmates.
- What is the current staff population? <u>90 staff members.</u>
- Staff M/F breakdown? (percentage) <u>42 females staff members and 48 male staff members</u>
- How many visitors per week? Approximately 234 visitors per week.
- What is the schedule for this facility hours/day, days/week, weeks/year. <u>24 hours a day 7 days</u> <u>a week</u>.
